THREE YEAR LIMITED WARRANTY

THREE YEAR LIMITED WARRANTY ON STUCTURE: Subject to the requirements, exclusions and limitations, Quality Cargo, LLC warrants that the Structure of each trailer operated by the original retail purchaser under normal use in the US will be free from defects in workmanship and materials for a period of one year from the date of purchase. "Structure" shall be defined as that portion of the trailer which includes the main frame, consisting of the bottom rails, cross members, side posts and exterior walls roof wails and bows, and the sub frame, exluding the floor boards and running gear.

EXCLUDED FROM THIS THREE YEAR LIMITED WARRANTY ARE : axles*, air conditioners*, electrical, plumbing, windows, doors, sealant, paint, undercoating, and fiberglass parts which are warrented for 90 days from the date of purchase by the original purchaser.* these products carry their own warranty.

NORMAL USE, NO REPAIRS OR ALTERATIONS : This **THREE YEAR LIMITED WARRANTY** covers only defects in original componets which arise from normal use. This **THREE YEAR LIMITED WARRANTY DOES NOT APPLY** if the trailer has been subjected to negligence, accident, abuse, misuse neglect, or overload or if the trailer has been damaged from repairs or alterations, and damage caused by improper hitch ball or tow hook up. Quality Cargo reserves the right for final determination whether or not product has been abused or misused.

NO REIMBURSTMENT WILL BE MADE TO ANY DEALER OR PURCHASER FOR REPAIRS MADE WITHOUT THE PRIOR WRITTEN CONSENT OF QUALITY CARGO, LLC.
